Editor's Note:

Thank you for taking this opportunity to read *Whidbey Weekly's Voter Guide* for the upcoming Nov. 8, 2022 general election.

Here are a few notes on our process:

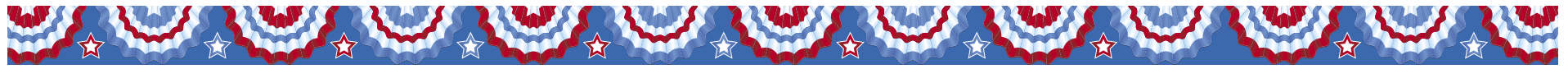
We included only Whidbey Island races with multiple candidates; we did not include races with a single, unopposed candidate. We did not include any Stanwood/Camano Island races.

We emailed candidates based on the contact information provided in the Island County Auditor's filing records and the Public Disclosure Commission. An initial email with questions was sent to each candidate Oct. 6, and a follow up/reminder email was sent Oct. 12. No emails bounced back to us due to incorrect addresses, etc. It is possible our emails wound up in junk or spam folders, but out of the 16 candidates in the eight races included in this guide, 15 candidates responded.

Candidates' responses are grouped by position; it is noted within that contest which candidate did not respond. Candidates were asked to keep their responses to each question to 150 words. Those responses over the word limit were cut off at the end of the sentence closest to the 150-word mark and it is noted the response ran over the limit. Other than editing for length, *Whidbey Weekly* did not change spelling or grammar in any of the candidates' responses; they appear as we received them.

We hope this guide will prove to be useful to Whidbey Island voters.

ISLAND COUNTY SHERIFF

Rick Felici

(Prefers Republican Party)

Current job: Island County Sheriff



Why do you seek election (or reelection)?

I am running for a second term as Sheriff, because I love the job. I get a sense of satisfaction from doing everything I can to improve the Sheriff's Office, our level of service to the community and the safety of Island County. We have an amazing team at the Island County Sheriff's Office and there is a lot of additional work to be done. We have more work to do to fill vacant positions and to find funding for more. We have accomplished a lot in the past four years and we are poised to accomplish a lot more.

What qualifies you to run for this position?

I have served as a patrol deputy, patrol sergeant, detective, detective sergeant and chief criminal deputy and I have been your Sheriff for almost four years.

I have taken advantage of many training opportunities throughout my career. As my career progressed, I began to focus on organizational leadership and management related training. I am a graduate of:

- The International Association of Chiefs of Police Legacy Leadership program
- The FBI LEEDA Executive Level Management Program
- I have Executive Level Certification in Leadership from the Washington State Criminal Justice Training Commission

In what ways, or through which organizations, have you served your community?

Oak Harbor Elks, Whidby Island Masonic Lodge, Central Whidbey Sportsman's Association, Holmes Harbor Rod and Gun Club, Ducks Unlimited Volunteer.

I have volunteered as a youth group advisor and I have assisted in coaching youth sports.

What do you believe is the biggest issue facing your community?

Drugs, mental health and homelessness and related crime are the biggest issues facing our community from a law enforcement perspective.

How do you intend to help deal with the aforementioned issue?

I believe that a combination of enforcement, education, and treatment is the most effective way to address these issues. I will continue to work closely with service and treatment providers to provide those services for those who are willing to participate and we will continue to take enforcement action whenever appropriate to address those who break the law.

What do you hope to accomplish through your public service?

I hope to have an actual impact on public safety, the Island County Sheriff's Office and the law enforcement profession. I would like to leave a legacy of leadership. I would like to leave my successor with a high quality, professional organization in a "turn key" state so that my successor can take the organization to the next level.

Why should people vote for you?

I believe that my experience, perspective, attitude and willingness to work outside traditional boundaries and political lines to find solutions sets me apart from my opponent. I have the training, experience and proven track record to continue to lead the team at the Island County Sheriff's Office to the next level. We have accomplished a lot in the past 4 years and there is a lot more to be done. I would be honored to serve this county for another term.

Lane Campbell

(Prefers Republican Party)

Current job: Deputy Sheriff



Why do you seek election (or reelection)?

For me it's pretty simple. Nothing significant has changed in the Sheriff's Office under the leadership of my opponent. We have still not filled our approved staffing numbers, public safety concerns are at an all time high, and there is a big disconnect between the deputies on the road and the Sheriff who has not been in a patrol car in over twenty years. Unless we get in front of some of our issues, we are in for a rough ride. The public needs a Sheriff that will listen and engage in the concerns of the community and lead. I am that Sheriff.

What qualifies you to run for this position?

I have over 40 years of law enforcement experience, with 32 years right here in Island County. I have thousand of hours of training, some of which are very specialized, from handling sexual abuse cases to fatal events on the road. I address mental health, substance abuse, homelessness, and crime on a daily basis, all of which are in the forefront of our society and usually run concurrent with each other. I was president of the Guild for a number of years and that provided me with knowledge and experience in contract employee negotiations, disciplinary actions, legal issues, and communication with the Commissioners and other County officials. I do have the skills, knowledge and understanding of the job requirements to effectively serve as your Island County Sheriff.

In what ways, or through which organizations, have you served your community?

As an officer of the law in our rural setting I am engaged with many organizations and actively participate in serving whenever I can. Since my hours vary and I take on many additional hours, I don't have as much time as I would like to spend. I do support CADA, Big Brothers Big Sisters, and other programs.

What do you believe is the biggest issue facing your community?

I believe the biggest issues we face in the community are concerns around public safety. Most of us moved here for the quiet, rural, quality of life, and for a great place to raise our families or retire to. There is a strong sense of community in Island County and at present, we don't have enough officers on duty to provide the amount of coverage we need to help ensure that all community members will get a quick response when they have a need for help. That is something that we must address as though our life depends upon it.

How do you intend to help deal with the aforementioned issue?

Public Safety must be addressed day one. The current Sheriff has had three years to fill the 43 openings, which will only take us a little above 2008 staffing numbers. Myself and the administrative team will work with the County Commissioners to look at utilizing some of the discretionary ARPA funds to create incentives or sign on bonuses along with specialty headhunters, so that we can hire lateral movement officers. We are going to need this so that those coming out of the Academy can be mentored. We can also look at some of the specialty training these candidates might offer so we can beef up areas where we are deficient. Also, since manpower is limited, I would like to work on a K9 program, less-than-lethal tools in each patrol car that will provide distance in difficult situations for safety, and work with the prosecuting attorney and our judges so we are on the same page at addressing public concerns. ****OVER WORD LIMIT**

What do you hope to accomplish through your public service?

I hope to bring a sense of peace and safety to all Island County residents. I hope to build an administrative team that has a strong relationship with our communities, where our department is highly visible and engaged at every age level. I want to hold public forums at each County District on a regular basis so that the community can share and know that their voices are heard. We have to have measurable goals, so that we can see how things are working. Things that aren't working will be evaluated and we can course correct and make it better. Something that has been missing for a very long time is a Sheriff that believes their elected position is to serve the community. We keep accepting the same thing expecting a different outcome, but my hope is to change that by being proactive, engaged and transparent.

Why should people vote for you?

I believe people should vote for someone they believe will bring the most to the table with regard to public safety concerns. Someone they believe shares their vision and expectations for the safety in Island County. I am a local Northwest son, and this area is my home... I am a guardian for all people. Some may not agree with everything I say, but I will always make the decisions that I believe will make my communities safe. My commitment to "Protect, Honor, Serve" has never wavered and if elected I will continue to serve our communities here in Island County. I would appreciate your vote on November 8th. Thank you.

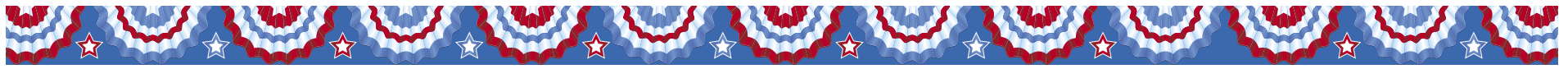
What do you hope to accomplish through your public service?

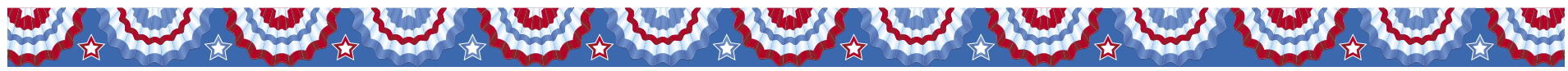

Dave Paul

Current job: Educator, Skagit Valley College



Why do you seek election (or reelection)?

I'm serving in my second term as State Representative, and I've worked hard to represent the values of our community. I am committed to building bridges that help connect diverse people, groups, and communities within our District and finding points of bipartisan consensus.

What qualifies you to run for this position?

Voters can trust that I will continue to listen to all constituents and work hard to find bipartisan solutions whenever possible. I am proud of the role I played in the College and Workforce Development Committee to expand the Washington College Grant and apprenticeship programs, providing better opportunities for all Washingtonians to have access to family wage jobs.

What do you hope to accomplish through your public service?

The engine of our economy starts with outstanding K-12, trade school, apprenticeship, community college, and university programs that generate living-wage jobs. I'm working with teachers and students to develop to strengthen high school advisory programs to better help students with their next steps after graduation, including exploring career opportunities, finding training programs, and applying for financial aid. I will continue my work with K12 career and technical training centers, high schools, apprenticeship programs, and community colleges to connect young people to summer employment that will lead living-wage jobs after graduation.

Why should people vote for you?

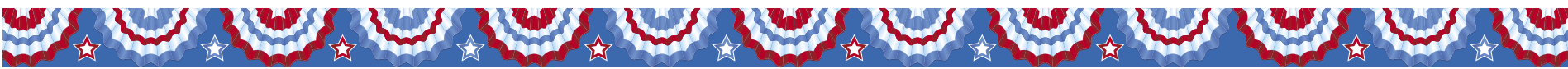

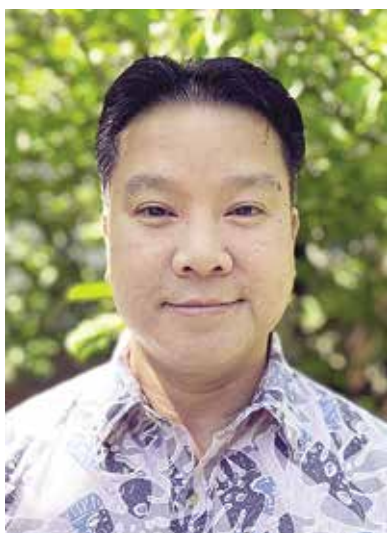


ISLAND COUNTY TREASURER

Tony Lam

(Prefers Democratic Party)

Current job: Chief Deputy Treasurer for the Island County Treasurer's Office.



Why do you seek election (or reelection)?

Wanda Grone is retiring as the Island County Treasurer. With her absence, the office and the county needs someone that has the knowledge and skill to manage the Treasurer's office, assist the County departments, and help the community.

What qualifies you to run for this position?

In 2008, I started working at the Island County Treasurer's Office as the Accountant. After the current Treasurer was elected in 2015, I was asked to become the Chief Deputy Treasurer. During those years, I handled the banking, investment and accounting responsibilities for the County and its taxing districts. I supervised the office staffs, and performed all cash management functions daily, as well as administered the external investment pool. Most importantly, I provided excellent customer service for individuals and business customers. All of my work experience will result in a smooth transition from one elected official to another in the County Treasurer's Office.

In what ways, or through which organizations, have you served your community?

I am a board member for the Swantown Ridge Homeowner's Association. This year would be my 3rd year as the Treasurer. In the past years, I occasionally volunteered at different community events.

What do you believe is the biggest issue facing your community?

Due to the high cost of living, many residents are having a hard time paying their property taxes.

How do you intend to help deal with the aforementioned issue?

At the Treasurer's office, we try to explain the options that are available to them. Depending on their circumstances, they can apply for certain exemptions or a payment plan. If an exemption is not available, having someone give them different options will at least lessen their worries.

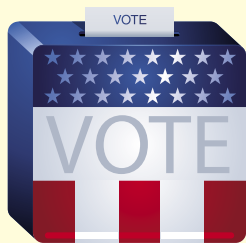

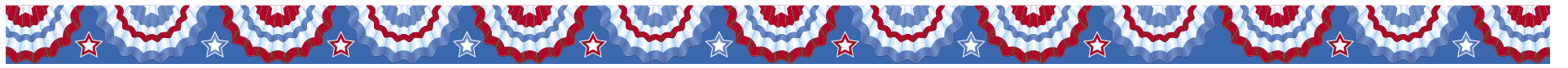

What do you hope to accomplish through your public service?

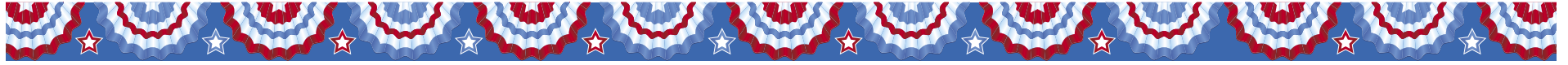

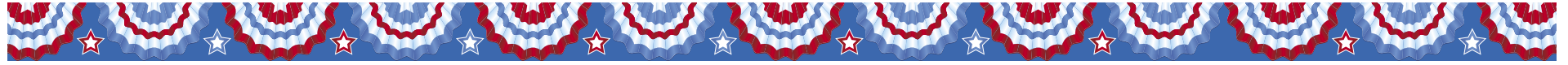

- Return postage prepaid for all elections**
Return postage is paid for all elections. Voters may use a ballot drop box or return ballots by postal mail at no cost.
- Same day registration**
Voters may register to vote in person up to 8:00 p.m. on Election Day.
- Electronic registrations**
Registrations submitted electronically (Motor Voter, Online, etc.) must be submitted no later than 8 days prior to an election.
- Mail In registrations**
Registrations submitted through the postal mail must be received by an Elections Official no later than 8 days prior to an election.
- Early registration**
Future voters age 16 and 17 may register to vote. Your registration will be kept "on hold" until you will be 18 years of age at the next election. At that time, you will be registered to vote.

ADA COMPLIANT IN-PERSON VOTING

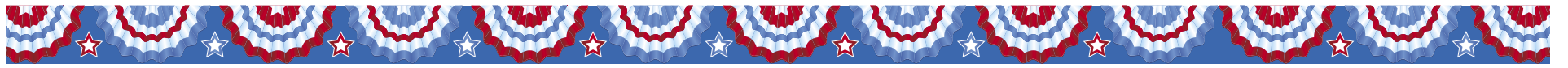
Beginning no later than 18 days before any election, the Elections Office (400 N. Main St., Coupeville) has an ADA Compliant Touch Screen Voting Device available. The voting device is available Monday through Friday, from 8 a.m. to 4:30 p.m. and on Election Day from 8 a.m. to 8 p.m.

These devices can display larger type or can provide an audio ballot to assist with visual or cognitive issues.

Voters can cast their ballot by using a select wheel or tactile button options. The equipment also supports a limited number of assistive switches, like foot pedals or sip and puff devices.

ASSISTANCE WITH VOTING

Voters can get personal assistance with voting by coming to the Elections Office (400 N. Main St., Coupeville). Voting assistance is confidential and requires no appointment. Voting assistance is available during office hours, and on Election Day from 8 a.m. to 8 p.m.

What do you believe is the biggest issue facing your community?

There are several significant issues for the Auditor's Office.

The most significant challenge to the Auditor's office without a doubt is election integrity. Questioning election integrity whether through disinformation or misinformation seems to have become the norm. The threats or actual filing of lawsuits against many County Auditor's Offices in attempts to discredit election results, as well as groups such as the Island County Republican Party adopting a resolution rejecting the 2020 Presidential Election further stresses the Auditor's Office.

Ensuring staff are provided with the proper training and processes is crucial. This is exemplified by audits from the State Auditor's office. In the audit for calendar year 2019, it would appear there was a lack of adequate technical training on generally accepted accounting principles (GAAP). In the audit for calendar year 2018, there was a finding that the "County Auditor's Office staff responsible for preparing the financial statements were unaware that interest earned is distributed to each special purpose district by the County Treasurer's Office."**OVER WORD LIMIT

How do you intend to help deal with the aforementioned issue?

As the new County Auditor, I would establish a baseline of the current practices of the Auditor's Office. In addition to analyzing current practices, I would do the following:

- Benchmark best practices from other counties and other relevant government organizations
- Develop processes that are not reliant upon individual people (tribal knowledge) and are integrated throughout the County.
- Invest in development of staff within the Auditor's Office to ensure competence and succession planning
- Evaluate secure IT solutions to fill gaps.

What do you hope to accomplish through your public service?

Public service provides me with several things. It offers me the opportunity to elevate Island County by ensuring there are more efficient and sustainable processes. In doing so, I help preserve the wonderful communities within Island County. This also serves to give me personal fulfillment through serving a larger purpose.

Why should people vote for you?

Voters should choose me based upon my devotion, integrity, and ethics. I would bring a different perspective to the office that thrives on continuous improvement and investment in staff.

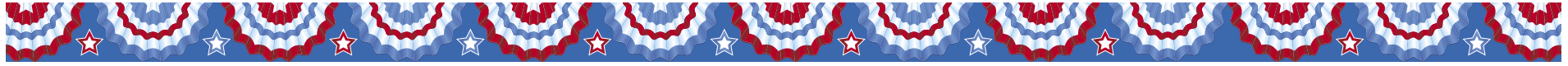
