Editor's Note:

Thank you for taking this opportunity to read *Whidbey Weekly's Voter Guide* for the upcoming Nov. 7, 2023, general election.

Here are a few notes on our process:

We included only Whidbey Island races with multiple candidates; we did not include water or cemetery districts or races with a single, unopposed candidate. We did not include any Stanwood/Camano Island races.

We emailed candidates based on the contact information provided in the Island County Auditor's filing records and the Washington State Public Disclosure Commission. An initial email with questions was sent to each candidate Oct. 5, and follow up/reminder emails were sent Oct. 9 and 11. No emails bounced back to us due to incorrect addresses, etc. For those candidates who failed to respond to our requests, it is possible our emails wound up in junk or spam folders. However, out of the 36 candidates in the 18 races included in this guide, 30 candidates responded.

All candidates were sent the same questions and were asked to keep their responses to each question to no more than 150 words. Those responses over the word limit were cut off at the end of the sentence closest to the 150-word mark. *Whidbey Weekly* did not change spelling or grammar in any of the candidates' responses; they appear as we received them. Candidates were also asked to include a photograph; nearly all of them did so.

It is our pleasure to provide this guide to Whidbey Island voters. We hope it will be a useful tool.

COUPEVILLE MAYOR

Meg Olson

Owner, Kingfisher Bookstore, Coupeville

Preferred political party? None Why do you seek election/reelection?

Our town's needs are increasingly complex, and we face growing challenges, from sea level rise and aging infrastructure to affordable housing. We need a professional town administrator with the training and skills to meet the community's needs for years to come. As mayor, I will bring positive leadership, work with stakeholders to achieve common goals, and with town council to draft policies that meet the community's current and future needs. I propose a reduction in the mayor's salary so that the town can hire a professional public administrator to implement those policies, build a strong team at town hall, ensure cost-effective programs, and work with department heads anticipating and planning for the community's long-term needs.



What qualifies you to run for this position?

With experience as a council member in a small city and two decades of experience in community news I have seen what works, and what doesn't. As owner of a small business and historic building on Front Street and long-time advocate for strong small communities, I am fiercely committed to ensuring Coupeville has a resilient, proactive government structure, and inclusive town government.

In what ways, or through which organizations, have you served your community?

Since we moved to Coupeville in 2018 I have served on the board of the Coupeville Historic Waterfront Association and volunteered for many of that organization's events, including Musselfest. I am a member of the Coupeville Lions Club and the Coupeville Chamber of Commerce.

What do you believe is the biggest issue facing your community?

The impact of sea level rise, affordable housing and balancing the challenges, and rewards, of increasing visitors to our town are issues the mayor's office needs to proactively address.

How do you intend to help deal with the aforementioned issue through the position you seek?

Information from a recently completed Sea Level Rise Vulnerability Assessment needs to be followed up expeditiously by a strategy to adapt to rising sea levels and other effects of climate change. In addition to seeking grant funding to develop such a strategy I would reach out to federal and state elected officials and agencies for their support in meeting this challenge. A housing needs assessment for the town of Coupeville should come before any zoning changes to address the availability of affordable housing. I would move forward with such an assessment while investigating creative ways to add housing options to the community without impacting its character. I would work collaboratively with regional initiatives highlighting regenerative tourism while addressing local needs from restrooms to parking.

What do you hope to accomplish through your public service?

I hope to establish the mayor's office as a community-forward position accessible to all citizens supported by an effective and experienced administration that efficiently manages tax dollars to meet community needs while ensuring pro-active regulatory compliance.

Why should people vote for you?

I have the experience, leadership skills and positive attitude to bring a new approach to town hall highlighting public process and efficient, effective administration.

Molly Hughes

Mayor of Coupeville

Preferred political party? Coupeville Mayor is a nonpartisan position

Why do you seek election/reelection?

I believe I have four more years of ideas and energy to contribute to Coupeville. We have many projects identified and/or in the works and I would like to continue working on them to see them through. It is very meaningful work to help identify the Town Council, town staff and our resident's priorities and I would like to continue to help make them a reality. I love coming to work every day, I love that the work is different every day and I love the staff I get to work with every day!



What qualifies you to run for this position?

I was an elected Coupeville Town Councilmember for 12 years before being elected Mayor. I have a solid record of getting work done and making good decisions on behalf of our residents. The Town has been fiscally responsible during my two terms and we have been very successful in obtaining grants to leverage our taxpayers money. Along with our great staff, I have been able to partner with other federal, state, county and nonprofit organizations to make the most of our resources. We have completed a strong Comprehensive Plan which reflects our residents' priorities and values. We have made many improvements to the town's equipment, infrastructure, facilities and streets and have a long-term plan to continue that work.

In what ways, or through which organizations, have you served your community?

There are many wonderful non-profits in Central Whidbey. I support many of them financially, am a member of some, or give a little time, but there are two I am very active with. I am a 21-year volunteer/President of our local food bank, Gifts from the Heart. I am also a 19-year member and Past President of the Coupeville Lions Club. I am dedicated to the 'service' mission of both organizations. As a result, I get to work with and serve a diverse group of Coupeville residents I might not otherwise have had the opportunity to meet.

What do you believe is the biggest issue facing your community?

There are several large issues impacting our community and the biggest difficulty to resolving them is a limited budget and the need to go to outside experts for help. Housing shortages, climate change, and infrastructure improvements come to mind as our biggest priorities right now. In all three instances we need financial assistance from the state and feds and help from specialists to come up with practical solutions. We are very good at finding grants and we have been very successful with contracting help from qualified specialists and consultants.

How do you intend to help deal with the aforementioned issue through the position you seek?

We will continue to look for outside funding to help with these large issues. We currently have four grants, totaling \$500,000 for work on wastewater discharge improvements, climate adaptability planning, and a housing inventory study. We will continue to look for 'best practices' from experts and advice from others who have completed similar work. We are a small town and we always start by looking at what has worked for others. Sometimes this work is more costly than we had hoped and takes longer to complete than we would like but we understand we are in the long game, and we have to keep planning for the future of our town.

What do you hope to accomplish through your public service?

I hope to keep Coupeville moving forward while understanding that our community values historic preservation and slow and thoughtful growth. We are proud of our small-town look and feel and we want to keep it. I hope to continue taking care of the Town's facilities and public spaces so they can be used and enjoyed for years to come. I hope to continue working with our businesses and partners so we can help each other reach our goals. I hope to continue to be a contributing member of our Town as the Mayor.

Why should people vote for you?

I love Coupeville and feel so lucky to live here! I have a long history of volunteering and working in our Town, I know the community, value our quality of life and respect our residents. I also love the job and look forward to coming to work every day! I would be honored to continue contributing to Coupeville as your Mayor.

Why do you seek election/reelection?



What qualifies you to run for this position?

From a professional perspective, I've practiced law with large firms on both coasts for 35 years, and have spent most of that time working through and litigating complex financial matters. I would love to have the opportunity to use that background to help the Port address some of the challenges that lie ahead. From a personal perspective, my wife and and I, though relatively new to the area, are interested in engaging with and contributing to the community, and this position would offer an opportunity to do that.

In what ways, or through which organizations, have you served your community?

My record of public service is frankly somewhat limited, as I've spent the bulk of my career practicing law with large law firms. In that context, though, I've been very active in pro bono matters, including serving as a disciplinary hearing officer for the Washington State Bar Association since 2014, with responsibility for presiding over hearings involving alleged attorney ethical violations. As my wife and I move toward retirement, we see positions like this one as offering an opportunity to increase our engagement with the community.



What do you believe is the biggest issue facing your community?

In my view, the biggest issue facing our community is the need to balance what we now have -- a semi-rural, physically beautiful, relatively uncrowded and pleasant place to live -- against the need for a form of economic development that is consistent with these characteristics while also offering meaningful opportunities for economic stability for residents. The pressure to compromise the former in service of the latter will only grow with time, and our community needs to be ready to deal with it.

How do you intend to help deal with the aforementioned issue through the position you seek?

The Port is only a part, and perhaps a small part, of that puzzle. But the Port is responsible for administering two assets that are awfully important to the Island's identity -- the Coupeville Wharf and Greenbank Farm. Using my background to help protect those assets and ensure their financial viability into the future is a way of contributing to the preservation of what makes this area so delightful. And if the Port can help in other ways -- perhaps through an expansion of its footprint, and with that an expansion of its tax base (which will help reduce the burden on the existing base) and allow for the exploration of other opportunities to provide value to the community -- it ought to be open to that.

What do you hope to accomplish through your public service?

Throughout my career, I have been the (perhaps not always deserving) beneficiary of the hard work and community-mindedness of others. As my professional responsibilities begin to wind down, the opportunity to take up that responsibility myself, and to add value to a place that I have come to cherish as my home, is one that I would find very rewarding.

Ultimately, we will all need to grapple with these forces but in the meantime, Langley should focus on:

- Innovative methods to preserve currently affordable housing
- Encouraging philanthropic or non-profit developments that can provide or access subsidization
- Developing incentives for multi-family infill projects that include the creation of affordable units as part of the overall development
- Partnering with public agencies like the Port of South Whidbey who can make suitable excess land available at favorable prices while still supporting their core missions.



Why do you seek election/reelection?

I'm switching my focus to policy issues which is my passion and the proper role of a City Councilmember. There are several issues in particular: 1) energy supply resiliency in the face of severe weather; 2) affordable workforce housing for our firefighters, teachers, restaurant workers, shop workers and others in the middle income workforce; 3) protection/restoration of our creeks and watersheds; 4) decreased traffic in town and safer streets for everyone; 5) increased government transparency and accountability; 6) creating a community in which all residents (black/white/red/



LGBTQ+/young/old/etc.) feel safe and welcome; 7) making Langley a possible location for young people to live; 8) budgeting so the City can be more responsive, and 9) creating a "Blue Zone" (see www.bluezones.com and Secrets of the Blue Zones - Netflix) where our seniors can live happier, healthier and longer; and more!

What qualifies you to run for this position?

While working for local government agencies on and off since 1986 I have seen what works, what doesn't and what kind of talent is needed on a team to be successful. In Colorado I served on a Planning and Zoning Commission, an Environmental Board, a regional transit agency board and was twice elected to a town council. I am proud of the progress Langley has made in upgrading our finance and record keeping policies and practices and also of the fine staff we have, including some new directors and the police I hired. Because of the experiences I have had working for cities like Ann Arbor, Michigan and Carbondale, Colorado I have developed a good sense for the skills and dedication needed to do various municipal jobs.

In what ways, or through which organizations, have you served your community?

I have volunteered and supported numerous non-profit organizations on South Whidbey over the years and became involved with the City of Langley during discussions about affordable workforce housing about four years ago. As mayor I represent the city on the Island County Council of Governments, a regional salmon recovery task force, a regional tourism committee, a regional transportation committee and I assist with several of the City's commissions.

What do you believe is the biggest issue facing your community?

With our population at just under 1,200 people we are stretched thin when it comes to providing the kinds of services that most people expect even in small towns. Currently the city is financially hurting; it took a few decades for us to get into this situation and it will take a 2 or 3 year financial strategy for us to get out of it completely. Like many small towns, we have not kept up with the increased challenges all small communities face in terms of fiscal health and record management. Without millions of dollars in grants we would not be able to keep up with even the basic maintenance of our water and sewer infrastructure. If we are unable to carefully grow our population and business base to keep our economy strong, then our water and sewer rates are likely to go up dramatically and we will fall behind on other basic services.

How do you intend to help deal with the aforementioned issue through the position you seek?

With a healthy and gradual slight increase in population, that includes younger people, including school aged children, we can help bring our community back into balance. Supporting our small business community, who provide nearly all of our sales tax revenue, which is the largest single revenue source for the City's General Fund. We need 30-50 new homes over the next few years for people already working here, this would benefit our tax base and support basic services as well as reduce the need for many to commute. We can manage a slightly larger population without increasing car traffic by increasing public transportation options, car sharing, and increasing safe opportunities for biking and walking. A slightly larger population will allow us to keep water and sewer rates from skyrocketing and provide additional funding for the city to improve our parks, protect our environment and provide other basic municipal services.

What do you hope to accomplish through your public service?

1) 30 units of affordable workforce housing in 2024, 2) providing solar electricity with battery back up to all city buildings and similar projects throughout the community, 3) a pilot project for passenger only ferry service to Langley/South Whidbey in 2024, 4) improved relations and cooperation with neighboring communities, including tribes, 5) increase preparation for disasters and infrastructure resiliency, 6) fewer and more efficient use of City commissions, 7) a new state-of-the-art financial management software system up and running in 2024, 8) removal of all City records from





Return postage prepaid for all elections: Return postage is paid for all elections. Voters may use a ballot drop box or return ballots by mail at no cost. Ballots must be postmarked on or before election day or they will not be counted.

Same Day Registration: Voters may register to vote in person from 8 a.m. to 8 p.m. on Election Day.

Electronic Registrations: Registrations submitted electronically (Motor Voter, Online, etc.) must be submitted no later than eight days prior to an election.

Mail In Registrations: Registrations submitted through the Post Office must be received by an elections official no later than eight days prior to an election.

Early Registration: Future voters ages 16 and 17 may register to vote. Registrations will be kept "on hold" until voters are 18 years of age at the time of the next election. At that time, they will be registered to vote.







My husband and I moved back to Oak Harbor over four years ago, after living in Shoreline for the prior 13 years. Since then, I have been actively engaged in serving in my local church (children's ministry and Home Group host) as well as serving as a small group leader in Bible Study Fellowship. My husband and I volunteered for our local community homeowners' association in the construction of easement access stairs.

Prior to our move, we lived in Oak Harbor for nine years when our four girls were young. I was an active member of PTA as well as a youth soccer coach, and Girl Scout cookie mom. Additionally, I helped with after school programs, field trips, and chaired fundraisers.

In Shoreline, I was active in PTA, serving as treasurer. I volunteered in the classroom, and for school events, and chaired fundraising events there as well.

What do you believe is the biggest issue facing your community?

Speaking of the school community specifically, academic achievement remains a concern. I want to work toward continuing the academic improvements that have been made since the pandemic shutdowns and work toward continuous improvement, and excellence. Oak Harbor School District isn't unique as test scores are a concern across the nation. The good news is that there was noted improvement in SBA scores (The state's standardized test for English Language Arts (ELA)/Literacy and math for grades 3-8 and 10) last spring. In fact, Oak Harbor improved more than the state average on most of the tests. That said, the students can achieve their best if they are motivated to do so, meaning we need to help create learning environments that address the whole child for both their academic success and well-being. Additionally, improved academic achievement requires an understanding of what is needed to best support our district staff as well.

How do you intend to help deal with the aforementioned issue through the position you seek?

By voicing this as a top priority, and I have. The current year's goals of the board and the superintendent include a focus on student academic achievement and well-being.

The district is in the process of developing a strategic plan, working with a core team from the district, which includes students, as well as community members. This will set the vision for the future, with high academic success as a core value. The Board is overseeing this process. We will monitor academic achievement and progress through quarterly disaggregated data reports from the superintendent. Another goal is to continue the collaborative partnership with DPAC (District Parent Advisory Committee) focused on student achievement and well-being.

I plan to be involved with the schools this year so I can better understand the student and staff experience. We have a lot to celebrate in Oak Harbor and I want to give voice to that.

What do you hope to accomplish through your public service?

My goals are to humbly serve, continue to learn, and be open-minded. As there is so much to learn,

Why do you seek election/reelection?

I am running to ensure that all of us who call Whidbey Island home have access to quality health care, to bring my forty years of health care experience to the board, and to ensure that the board fulfills its financial and other oversight responsibilities. I am running because our Hospital Board has no health care professionals among its five members. Our community needs the voice of a seasoned health care leader among its hospital commissioners, and I know health care from the perspective of a bedside nurse, manager, and leader who interfaced with every aspect of hospital staff for years. Finally, I am running because we need someone who welcomes new ideas and possibilities and is selected by the people, not the commissioners.



What qualifies you to run for this position?

I have lived on Whidbey Island for over eight years – I know our community and the needs of our hospital. I am a career registered nurse with over 40 years' experience in critical care, emergency, and management roles. I served my country around the world for 21 years as an active-duty and reserve Air Force nurse and retired as a Lieutenant Colonel. For the last three years I have been President of WhidbeyHealth Foundation, during which time our team and generous community raised over \$2 million for life saving and quality care equipment for WhidbeyHealth. I have worked in large and small civilian hospitals across the US and served on several nonprofit boards as a member and in leadership positions. Lastly, I have a Bachelor of Science degree in Nursing from Thomas Jefferson University and a Master's Degree in Health Systems Management from Georgetown University.

In what ways, or through which organizations, have you served your community?

I served our country for 21 years as an Air Force nurse, on active duty and as a reserve officer, and retired as a Lieutenant Colonel. During that time and afterwards I supported numerous military spouse and dependent programs in the US and at overseas locations. In 2014 I was awarded the Joint Chiefs of Staff Distinguished Public Service Award, the highest civilian public service award bestowed by the Chairman of the Joint Chiefs of Staff. After moving to Whidbey Island in 2015 I worked on the levy drive committees for the fairgrounds in Langley and the hospital in Coupeville. I also served as a board member for the Whidbey Island Center for the Arts from 2019-2022. I joined WhidbeyHealth Foundation in 2019, was elected president in 2020, and since then have led a team that's raised over \$2 million to meet our hospital's needs.

What do you believe is the biggest issue facing your community?

The biggest healthcare issue facing our hospital community is financial balance. Healthcare across the nation is struggling due to the high cost of staff, materials, and low reimbursement from insurance companies. WhidbeyHealth is no exception. Our new hospital CEO and CFO deciphered the previous financial puzzles and restructured the billing system, but challenges remain. We need more people to make WhidbeyHealth their healthcare of choice to increase the mix of insurance payers. Another challenge is the navy base hospital being reduced to a clinic, which pushed all military in-patient care and some outpatient care into the community. Unfortunately, Tricare military insurance reimburses at a lower rate than Medicare, which further exacerbates the financial balance when combined with our high number of Medicare and Medicaid patients. We pride ourselves in providing excellent health care to these populations, but must obtain the highest level of payment from each insurance program.

How do you intend to help deal with the aforementioned issue through the position you seek?

As a commissioner I will closely monitor expenses, revenues, and liabilities, and look for solutions and new ideas from across the State and US. I will encourage our community to make Whidbey-Health their healthcare of choice. We need to use our health system if we want it to be here when we need it. Lab work, x-rays, mammograms, outpatient procedures, rehabilitation, and more are available at WhidbeyHealth. A specialist in Edmonds can order labs, radiology, or IV therapy that can be administered in our hospital. That benefits WhidbeyHealth's bottom line, and you don't have to sit in ferry lines or drive around. The national problem of low reimbursement from military healthcare insurance (Tricare) is getting the attention of more leaders in Washington DC. We need to amplify our voices, work with our elected officials, and address the underfunding that hurts our military families and community hospitals.

What do you hope to accomplish through your public service?

I hope to continue the legacy started over 50 years ago that brought quality, accessible, and independent healthcare to Whidbey Island. I want to develop community forums for the administration and commissioners to meet the public, share information, and listen to their concerns. I don't think the only way to see commissioners should be at a monthly meeting with a 3-minute time limit for comments. The public should have full financial transparency and awareness of challenges the hospital faces. One example is the low reimbursement from military insurance, which has a tremendous impact on a small health system like ours. I want to amplify these needs to our representatives in Congress and the Dept of Defense to obtain legislation that will provide financial support for small hospitals that care for military patients. Whidbey Island supports our military and we need support from Washington DC. I'm ready to do this.

Morgan Cooper

Current Board Commissioner, Position 1 Preferred political party? Bi-Partisan Position

Why do you seek election/reelection?

To continue my work as I have been seated since February 1st, 2023

What qualifies you to run for this position?

I have over 18 years of internal hospital marketing along with providing education and representation of specialty services like cardiology, orthopedics,

radiology, bariatrics, behavioral health, and clinic administration experience in weight loss, bariatrics, and plastic and reconstructive surgery for cancer patients. Our clinic at Swedish was one of the first to launch EPIC and we spent a year and a half fine-tuning billing and provider documentation to support those services, measuring staff needs, growing support services, and hospital referrals. I have been active in establishing best practices, and employee engagement while managing quality care for patients. Not only do I have experience, but I am a community member who feels we need a committed voice that will truly represent the residents of the island. All of this is a plus for the board and the community as I am the only one currently with this skill set.

In what ways, or through which organizations, have you served your community?

I have been thoughtfully engaged in my community in a number of ways since 1973. Through civic organizations, fundraising efforts, and special community events, I have always given my time and energy to help whether by my former disc jockey profession, my graphic design, and marketing services. Some of these include: BB/BS, The Burned Children's Foundation, Seattle Children's Hospital, Hydros for Heroes, The Backpack for Kid's Food Program, and the Oak Harbor Music Festival, are only a few.

What do you believe is the biggest issue facing your community?

Our rural hospital has faced many significant challenges that are multi-level but they do "live together" to promote a healthy community hospital. Rural hospitals across the state struggle due to many of the same challenges and need to think outside of the box to correct their impact. We have a heavy Medicare, Medicaid, and Tricare payor mix which pays pennies on the dollar, and in many cases, we lose money providing care. It is important that we advocate to our legislators for opportunities to improve reimbursements. Billing, proper coding, and timely submission of services has been addressed and we are currently running 39-52 days cash-on-hand, as opposed to 3 days. Employee retention and adding quality providers to expand our range of services are also critical to the future of WhidbeyHealth. The final piece is to provide more transparency and regain public trust so they will utilize our services.

How do you intend to help deal with the aforementioned issue through the position you seek?

I was seated on February 1st this year and I have been working on a number of committees. I am on the board for the Finance Committee with efforts to evaluate past scenarios and to bring accountability/transparency to former issues. Some were: billing issues, improper coding of services, and no one to follow up if charges were denied. Some billing was at 180 days to a year in receivables. Under the former CEO, we did not have a financial goal or monthly financial report. This should never happen again. You cannot meet goals or measure success if you do not have information. The board also provides guidance to the CEO so I am excited with our newly hired CEO who is really proactive in providing leadership. I also sit on the Quality Improvement Committee that keeps track of and measures hospital care, employee engagement, and patient care initiatives and results.

What do you hope to accomplish through your public service?

I hope to build a stronger community connection to our rural healthcare system. WhidbeyHealth can be profitable, healthy, and vibrant while meeting the needs of its community. I hope to accomplish this by providing community access, increasing education and resources, and connecting our community in a healthy way. I self-funded my campaign so that I could demonstrate my neutrality and desire to serve my community. The hospital belongs to all of us and as a board member, I'm a community member, just like we all are and I will carry your voice, your concerns, and be watchful and mindful of the delicate balance needed in order to provide excellent healthcare for all.

Why should people vote for you?

I had my first child at WhidbeyHealth eons ago, I have been a part of this community for the better part of my life. I raised my family here and I am a committed community member with hospital, healthcare, and marketing experience. I have no agenda but to ensure that our hospital is well-managed and accountable to the community it serves.
